Rebate Application Form

The Town of Orangeville offers its residents and businesses a \$60 rebate, including HST, when an existing toilet is replaced with a more water efficient model as approved by the Town.

To be eligible for the rebate offer, the homeowner or business must:

- ✓ meet and agree to the terms and conditions of the Town's Toilet Replacement Program;
- ✓ be connected to the municipal water and/or sanitary sewer system and receive a water bill;
- ✓ purchase and install a low-flow toilet as approved by the Town of Orangeville & compliant with O. Reg 332/12;
- ✓ replace a toilet with a flush volume of 6 litres or larger with a WaterSense® certified toilet;
- ✓ fill out this application form and submit it with the **original** sales receipt;
- ✓ be available for an on-site inspection of old and new toilets; and
- ✓ **disassemble** old toilet, attach provided garbage sticker and place old toilet at curbside for pickup.

NOTE: 1. The program **does not apply** to new bathroom additions.
 2. **Multi-unit residential (apartments)** must register with Town for eligibility before replacing their toilets.

TERMS AND CONDITIONS

1. The Toilet Replacement Program will be administered by the Public Works Department of the Town of Orangeville.
2. The toilets in new bathroom additions **do not qualify** for the rebate. The Building Code requires that any additional bathrooms must have a low flow toilet. Not necessary to provide a rebate.
3. **Multi-unit residential (apartments)** must contact the Town of Orangeville at **(519) 941-0440, ext. 2269** to qualify and register before replacing their toilets.
4. Submission of an application does not guarantee a rebate. Applications are processed on a first-come, first-served basis. The program will be reviewed at regular intervals and adjustments may be made as Council directs.
5. The program is subject to cancellation at any time, without notice, and is limited to available funds.
6. Toilets eligible for the rebate(s) have to be approved by the Town of Orangeville.
7. Payment of a rebate under the program will be conditional on:
 - a) Complete installation of the number of WaterSense® certified toilets indicated on the Rebate Application Form;
 - b) A home inspection of the installed WaterSense® certified toilet(s) and removal of the old toilet(s) to ensure that eligible toilet(s) have been installed/removed and
 - c) Disposal of each old toilet through curbside pickup.
8. The Town of Orangeville reserves the right to limit the number of rebates in any building with respect to which it offers a rebate under the program.
9. By submitting an application, the applicant agrees to release, waive and forever discharge the Corporation of the Town of Orangeville of and from all claims, actions, causes of action, losses, damages, expenses and costs of any nature whatsoever arising out of or related to the applicant's participation in the program. The applicant further acknowledges that the Town is not responsible for the selection of and does not warrant the performance of or accept any liability for the operation or non-operation or manner or form of installation of the toilet replacement equipment under this program.

Steps to Receive a Rebate:

1. Review Program terms and conditions to see if you are eligible;
2. Purchase and install a WaterSense® certified toilet(s) which replaces an existing toilet with a flush volume of 6 litres or larger;
3. Complete and return the Rebate Application Form and the **original** sales receipt(s) to the Public Works Department and arrange an on-site inspection time;
4. Take apart and place old toilets at the curb for pickup with regular garbage collection; and
5. Subject to your compliance with the Terms and Conditions, a rebate cheque will be mailed to you within two weeks.
