BY-LAW NUMBER 25-97

**BEING A BY-LAW TO AMEND ZONING BY-LAW 22-90 TO REMOVE THE HOLDING SYMBOL (H<sub>1</sub>) FROM A PORTION OF THE LANDS DESCRIBED AS PART OF LOT 2, CONCESSION 1 WEST OF HURONTARIO STREET (95 FIRST STREET)**

WHEREAS the Corporation of the Town of Orangeville deems it appropriate to amend Zoning By-law No. 22-90 to remove the holding symbol (H<sub>1</sub>) from a portion of the lands described as Part of Lot 2, Concession 1 WHS;

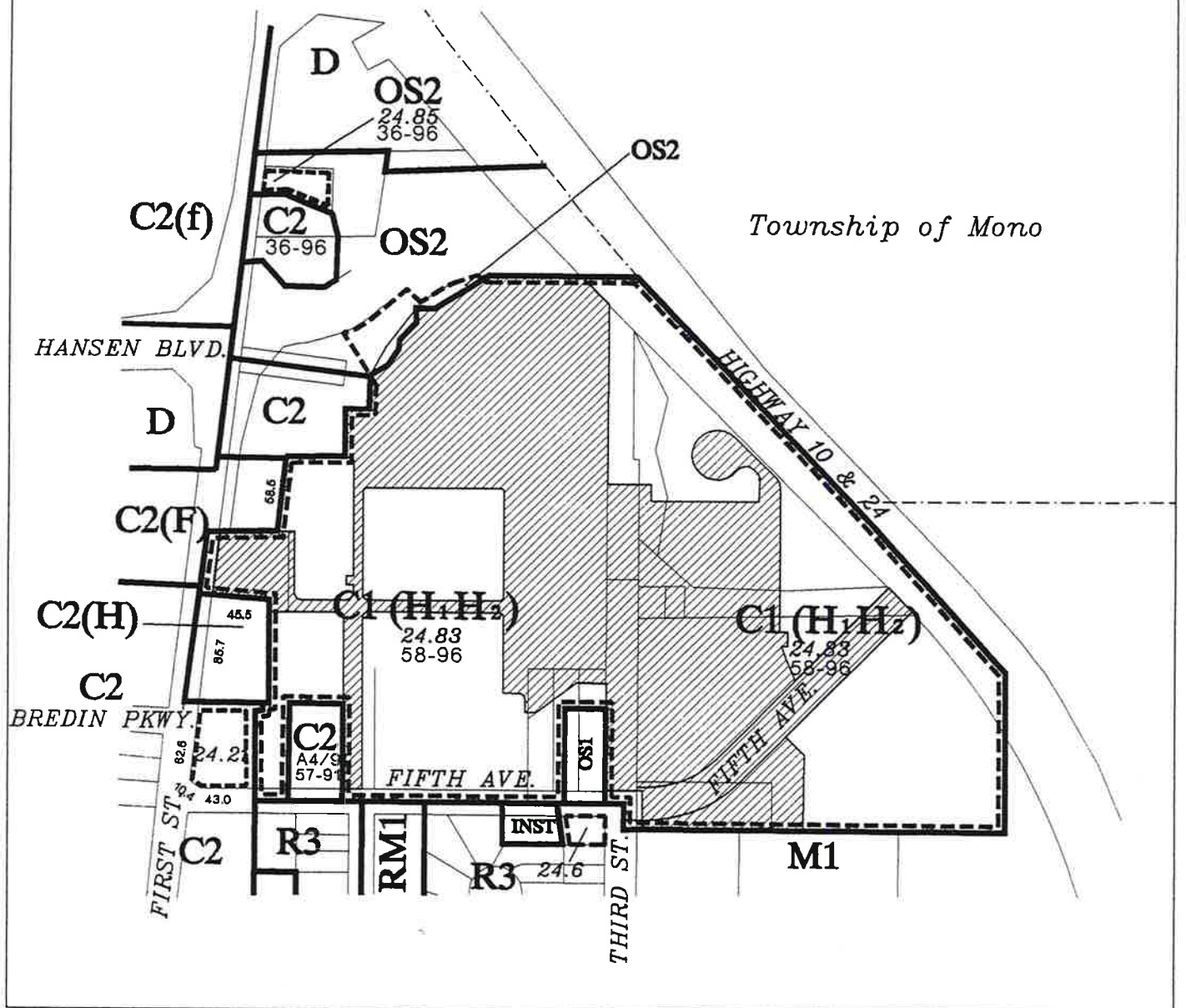
NOW THEREFORE, THE CORPORATION OF THE TOWN OF ORANGEVILLE BY THE MUNICIPAL COUNCIL THEREOF ENACTS AS FOLLOWS:

1. THAT Zone Maps A4 and B4 of Zoning By-law 22-90 are amended by removing the holding symbol (H<sub>1</sub>) from the lands shown in hatching on Schedule "A" to this By-law, and being Part of Lot 2, Concession 1, West of Hurontario Street; All of Third Street (closed by By-law 58-72, Inst. MF 50945); Part of Third Street (closed by By-law 927, Inst. MF 50862), Part of Agricultural Fairgrounds Lot, Registered Plan 251; All of Lot 39, Part of Lots 35, 36, 37, 38, 40 and 41, Registered Plan 275; Part of Lots 10, 11, 12, 13, 14, 15, 16, 17 and 18, Block 16, Part of Lots 10, 11, 12, 13 and 14, Block 17, All of Lots 6 and 12, Part of Lots 1, 2, 3, 4, 5, 7, 8, 9, 10, and 11, Part of Lane (closed by By-law 1958, Inst. 15132), Block 18, All of Lots 1, 2, 3, 4, 5, 6 and 7, Part of Lots 8 and 9, Block 19, All of Lots 1, 2, 3, 4, 5, 6, 7, 8, and 9, Block 20, All of Lots 1 and 2, Part of Lots 3, 4 and 5, Block 21, Part of Second Street, Part of Third Street, Part of Fourth Street (closed by Judge's Order 8809), Part of Fifth Street (closed by Judges Order 8809), Registered Plan 222, Town of Orangeville, County of Dufferin (95 First Street).
