

THE CORPORATION OF THE TOWN OF ORANGEVILLE

BY-LAW NUMBER 127-97

Being a by-law to amend Zoning By-law number 22-90, as amended, (Lots 15 and 16, Registered Plan 27A, Khwaja and Amna Ajib, OPZ 10/97).

WHEREAS THE CORPORATION OF THE TOWN OF ORANGEVILLE DEEMS IT APPROPRIATE TO ENACT THIS BY-LAW;

NOW THEREFORE THE CORPORATION OF THE TOWN OF ORANGEVILLE BY THE MUNICIPAL COUNCIL THEREOF ENACTS AS FOLLOWS:

- 1. THAT Zoning Map B5 of Schedule "A" to By-law 22-90, as amended, is hereby amended in accordance with Schedule "A" hereto.
- 2. THAT Section 24.22 of By-law 22-90, as amended, is hereby amended to read as follows:
 - "24.22 Notwithstanding the provisions of Section 11B of this by-law, the following regulations shall apply to lands described as Part of Lots 15 and 16, Registered Plan 27A:

Permitted Uses

A single detached dwelling

A home occupation in accordance with the provisions of Section 5 hereof.


Regulations for a single detached dwelling with less than 9.1 metres of frontage

1)	Lot area (minimum)	300 sq. metres
2)	Lot frontage (Minimum) - interior lot	8.5 metres
3)	Front yard (minimum)	6.0 metres
4)	Interior sideyard (minimum) - on one side of the dwelling - on other side of dwelling - combined side yard	1.2 metres 0.1 metres 1.3 metres
5)	Rear yard (minimum)	4.5 metres
6)	Building height (maximum)	9.2 metres
7)	Coverage (maximum)	45%
8)	Ground floor area (minimum) - one storey - two storey	90 sq. metres 55 sq. metres


