

The Corporation of the Town of Orangeville

By-law Number 112 - 2013

A by-law to amend Traffic by-law No. 78-2005 to establish stop sign locations and prohibit parking.

Whereas the *Municipal Act, 2001, S.O. 2001, c.25, S.11* authorizes a municipality to pass by-laws respecting matters within the jurisdiction of highways, including parking and traffic on highways;

And Whereas the Council of the Corporation of the Town of Orangeville deems it expedient to amend By-law No. 78-2005, as amended, to establish stop sign locations and prohibit parking;

Be it therefore enacted by the municipal Council of the Corporation of the Town of Orangeville as follows:

1. That Schedule "A" (parking restrictions) of By-law 78-2005, be amended by adding the following:
