BY-LAW NUMBER 36-2011

**A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 78-2005
TO ESTABLISH STOP SIGNS AND PARKING
RESTRICTIONS AT VARIOUS LOCATIONS**

WHEREAS the *Municipal Act, 2001, S.O. 2001, c.25, S.11* authorizes a municipality to pass by-laws respecting matters within the jurisdiction of highways, including parking and traffic on highways;

AND WHEREAS the Council of the Corporation of the Town of Orangeville deems it expedient to amend By-law No. 78-2005, as amended.

BE IT THEREFORE ENACTED by the municipal council of the Corporation of the Town of Orangeville as follows:

- 1. THAT Schedule "A" (parking restrictions) of By-law 78-2005, be amended by adding the following:

| Sandringham Circle | West | Sandringham Circle and the south limit of 50 Sandringham Circle | Anytime |
| Sandringham Circle | North, west and south | From the east limit of 50 Sandringham Circle to the north limit of 80 Sandringham Circle | Anytime |
| Sandringham Circle | South | Opposite 50 Sandringham Circle to approximately 10 metres west of the entrance into the sanitary sewage pumping station | Anytime |
| Sandringham Circle | West (abutting sanitary pumping station) | Approximately 10 metres north and 10 metres south of the fire hydrant | Anytime |
| England Avenue | North | County Road 23 (B Line) and Sandringham Circle | Anytime |
| Maude Court | East and south | England Avenue and the east limit of 20 Maude Court | Anytime |
| St. Paul's Place | North and west | Sandringham Circle and approximately 15 metres east of the south limit of 21 St. Paul's Place | Anytime |

| Young Court | North and east | County Road 23 (B Line) and the limits of 57 Young Court | Anytime |
| Young Court | East, north, west and south | 57 Young Court and 60 Young Court | Anytime |


