BY-LAW NUMBER 28-2011

**A BY-LAW TO APPROVE THE INSTALLATION OF TRAFFIC SIGNALS AT THE INTERSECTION OF HANSEN BOULEVARD AND AMELIA STREET AND TO AMEND BY-LAW 78-2005 (signalized intersections).**

WHEREAS Section 144 (31) of the Highway Traffic Act, as amended, allows for the installation of traffic control signals in accordance with an approval obtained from a person designated to give such approvals by the municipality or other authority that has jurisdiction over the highway or the intersection;

AND WHEREAS Triton Engineering Services Limited was authorized to undertake and approve the design of traffic signals at the intersection of Hansen Boulevard and Amelia Street, in the Town of Orangeville;

AND WHEREAS the signal design has been recommended for approval by the Director of Public Works;

BE IT THEREFORE ENACTED by the municipal council of the Corporation of the Town of Orangeville as follows:


1. THAT traffic signals be installed at the intersection of Hansen Boulevard and Amelia Street.
2. THAT the Clerk be authorized and instructed to sign the legal approvals on behalf of The Corporation of the Town of Orangeville and to affix the corporate seal thereto.
3. THAT the wording of Section 7.5 (signalized intersections) of By-law 78-2005, be deleted and replaced with the following:


“Signalized Intersections – The intersection on the highways set out on Schedule “G” of this By-law are hereby designated as signalized intersections.”

4. THAT Schedule “G” (signalized intersections) of By-law 78-2005, be amended by adding the following:

Hansen Boulevard and Amelia Street
